Vendors must list the following information on the Certificate of Insurance in the area titled "Description of Operations" and Endorsements: MoPRIDE, Inc., its Officers, Agents, Employees & Volunteers are named as additional insured per the attached endorsement. Project: World AIDS Day 2019. Vendors shall provide MoPRIDE, Inc. with separate endorsements evidencing proof of MoPRIDE, Inc.'s additional insured status as to both the general liability and automobile liability insurance policies. If applicable, Automobile Liability insurance with a minimum limit of liability per occurrence of \$1,000,000 for bodily injury and property damage. This insurance shall cover any automobile for bodily injury and property damage. If applicable, Proof of Worker's Compensation Insurance for vendors who will have employees working during the event. All endorsements referenced above must include the applicable policy number.
